#### **GENERAL REGULATIONS**

- 1. Membership \$10 per person
- 2. All entries being made and monies being paid the section convenor will deliver to the exhibitor card showing the class and distinguishing number which must be securely attached to the exhibit so as to be easily seen by the judges. Any exhibits having no ticket will not be recognised as entered for competition.
- 3. No exhibit to be removed from the ground or hall before 4.00 pm without the consent of secretary or steward of section. Any person offending against this rule will be disqualified and forfeit prizes.
- 4. All exhibits must be the bona fide property of the exhibitor for at least one month prior to the show except where otherwise specified.
- 5. All exhibitors must place the exhibits in places allotted or as directed by the stewards prior to judging or be disqualified.
- 6. Protests in writing, and accompanied by a deposit of \$50.00 must be lodged with the Secretary within half an hour after the event is decided; deposit to be forfeited to the Secretary if the protest is not upheld.
- 7. Where there is any doubt existing as to the bona fide ownership of any exhibit, the committee has the power to withhold the prizes until one of both parties make a declaration before a J.P. as to the ownership of the exhibit, being the bona fide property of the exhibitor.
- 8. No person will be allowed inside the ring or hall during the judging, except judges, reporters, secretaries and persons in charge of stock exhibits, without the written consent of the Secretary.
- 9. Any exhibitor or attendant with an exhibit giving annoyance to the judge or making use of insulting language to the committee or secretary shall be liable to have his/her exhibits disqualified.
- 10. Name of prize-winners will be affixed by convenors after judging.
- 11. No entries will be accepted for entire horses except where specified.
- 12. No persons shall enter the ring or have any personal communication with the judges before or whilst in execution of their duties, and on such offence bring prices he or she shall be disqualified. Should any information be required by the judges, it will be obtained through the chief steward.
- 13. Stewards are directed to strictly carry out the rules regarding names etc., of exhibitors during judging.
- 14. Every care will be taken of exhibits, but the society incurs no responsibility.
- 15. Spaces for sideshows etc will be allowed on payment of fees. Any person or persons refusing payment of fees when demanded by the secretary or assistant secretary will be removed from the ground and refused readmission
- 16. The secretary or assistant secretary will regulate the stands for all exhibits, sideshows and displays by way of advertising. In no case will they be allowed to encroach on another's space. Persons offending are liable to be expelled.
- 17. The judges shall have the power to withhold a first prize from any exhibit they consider not worthy, but award a lower prize in lieu thereof.
- 18. Prize money paid on show day at the discretion of section CONVENOR after 4pm.
- 19. All admission tickets/stamps to be produced at the gate if demanded by the gatekeeper.
- 20. No entry will be accepted where exhibitor requests the secretary to keep such entry money out of prizes, unless otherwise provided for.
- 21. No exhibit is eligible for prizes in more than one class.
- 22. The wool judges have the power to shift wool from one class to another if they consider it out of its' class through wrong count of wool.
- 23. The society will not be responsible for any accidents or mishaps which may occur in the show ring or on the ground.
- 24. The committee may require any horse in respect of which current official height certificate is produced to be measured on the day and such measurement shall be binding on all parties.
